Police Chief Bill Joyce stated that on July 11<sup>th</sup> Comcast is supposed to have the phones at the new station up and running and that Martin Whalen is moving the copier. He stated that Jeff Murphy is doing all the electronics and stated that he is doing a phenomenal job.

Public Works Director Rick Wehrle stated that his crew is continuing to flush hydrants, paint curbs, and crosswalks. He stated that the Bloom Township summer employees will be helping for six weeks.

Deputy Chief Tim Wehrle stated he received notification from IDOT regarding the DUI & seatbelt enforcement grant and stated that the state is supposed to be releasing funds.
