# APRIL 5, 2021 REGULAR MEETING

## TRUSTEE/COMMITTEE REPORTS:

Deputy Fire Chief Bednarek stated that Chief Vlietstra was doing well. DC Bednarek stated that there were 113 calls in the month of March, 75 were EMS and 38 fire service. DC Bednarek stated that Colby Lemm started in the department as our new Metro employees and welcomed him.

Police Chief Joyce stated that the application process was over and that 8 applications were received, four within the department. Chief Joyce announced that the Police Department was awarded an IDOT grant for 2021 in the amount of \$19,660.00 to be used for DUI and seatbelt enforcement.

Director Martin stated that his department had a total of 14 water main breaks, 2 valve replacements, 1 valve repair, 2 B-Box replacements, 1 B-Box repair, 1 sanitary sewer repair, and 1 storm sewer repair since January 1<sup>st</sup>.

Deputy Chief Kozinski stated that there were 609 calls for police service in March 2021.
