

REHAB PERMIT MODIFICATION FOR WATER USAGE AGREEMENT

WATER USAGE ONLY AVAILABLE IF A REHABILITATION OR NEW CONSTRUCTION PERMIT HAS BEEN OBTAINED; THE EXISTENCE OR PROGRESS TOWARD REMEDIATION OF ANY BUILDING CODE VIOLATIONS; THE PROPERTY MUST HAVE A NEW MASTER METER INSTALLED WITH A WORKING AMI RADIO TRANSMITTER PAID BY THE OWNER OF SAID PROPERTY.

30 DAYS FROM THE DATE OF THIS AGREEMENT, WATER WILL BE SHUT OFF UNTIL OCCUPANCY IS GRANTED. IF FURTHER WATER SERVICE IS NEEDED, A PROGRESS CHECK OF THE PREMISES IS NEEDED TO SHOW A REASONABLE AMOUNT OF COMPLETED BUILDING CODE VIOLATIONS BEFORE FURTHER WATER SERVICE IS GRANTED. ONLY THE BUILDING DIRECTOR CAN APPROVE AN EXTENSION OF THIS AGREEMENT AND THE FEE IS PAID.

THE WATER FEE IS \$50.00 FOR 30 DAYS OF SERVICE ONLY, NOT TO BE PRORATED. THIS FEE MUST BE PAID AGAIN IF WATER SERVICE IS GRANTED BY THE BUILDING DIRECTOR. IN ADDITION TO THIS FEE, ACTUAL WATER USAGES REGISTER ON WATER METER WILL BE PAID ON THE FIRST WATER BILL ONCE OCCUPANCY IS GRANTED.

THIS AGREEMENT DOES NOT INCLUDE GARBAGE PICK-UP. GARBAGE SERVICE WILL BE GIVEN AT TIME OF OCCUPANCY.

NO ONE CAN LIVE IN THE HOME UNTIL OCCUPANCY IS GRANTED.
