TYPE OF LICENSE APPLIED FOR

_____ Video gaming terminal operator license - \$1,000.00 PER TERMINAL per year (includes any person who owns or leases a video gaming terminal for use in the Village of South Chicago Heights.

_____ Video gaming terminal establishment license - \$75.00 PER TERMINAL per year (includes any person who owns/operates any place of business in which a video gaming terminal is located in the Village of South Chicago Heights.

Sec. 50-378. – Definitions.

Terminal Operator: Any individual, partnership, corporation, or limited liability company that is licensed under the Video Gaming Act, 230 ILCS 40/1 et seq., and that owns, services, and maintains VGTs for placement in licensed establishments, licensed truck stop establishments, licensed large truck stop establishments, licensed fraternal establishments, or licensed veterans establishments.

Licensed Establishment: any location within the Village that offers for play a VGT as authorized by the State of Illinois Video Gaming Act for which a license is required by the Village of South Chicago Heights Code of Ordinances.

It shall be unlawful for any "Terminal Operator" as defined in Section 50-378 above to lease, maintain, operate or otherwise place any VGT as authorized and licensed pursuant to the State of Illinois Video Gaming Act within the corporate limits of the Village of South Chicago Heights without first obtaining an annual VGT "Terminal Operators" license issued by the South Chicago Heights Village Clerk. Said "Terminal Operators" license shall be required for each VGT leased, maintained, operated or otherwise placed within the Village's corporate limits. All such licenses shall expire on April 30th of each year. The fee for such license shall be one thousand (\$1000) per VGT. Said license fee is imposed directly upon the "Terminal Operator". The issuance of such license is a condition precedent to the issuance of the annual local liquor license to the "licensed establishment" in which the VGT(s) will be placed.

LOCAL REGULATIONS

Eligibility - Only Class A, B & J liquor license holders are eligible to apply for a Video Gaming Establishment License.

Transfer prohibited- A license or registration issued pursuant to this section may not be transferred, sold or assigned to any other person, corporation, association or other entity; nor shall such license be transferred to any location other than that listed on the application.

All video gaming devices shall be in an area restricted to persons 21 years of age or older. No licenses establishment may cause or permit any person under the age of 21 to use, play, or operate a video gaming device.

The licensed establishment shall fully comply with the Illinois Video Gaming Act (230 ILCS 40/1, et seq.) and all laws, rules, restrictions, and regulations imposed by the State of Illinois.

ITEMS REQUIRED

1. Copy of a valid State of Illinois Gaming Board License.
2. Copy of a valid State of Illinois Liquor License.
3. A site plan clearly indicating the proposed location of all Video Gaming Terminals and type of barrier to be utilized to segregate the area.
4. Certificate of Insurance listing the Village of South Chicago Heights as additional insured.
